The Volunteer and Guardians desire that the Volunteer work as a volunteer for BELLWBIF and engage in the activities related to being a volunteer (the "Activities"). The Volunteer and Guardians understand that the Activities may include constructing and rehabilitating residential buildings, working at the BELLWBIF facilities, and working at public facilities related to the We Build It Forward program.

The Volunteer and Guardians do hereby freely, voluntarily, and without duress execute this Release under the following terms:

RELEASE AND WAIVER. The Volunteer and Guardians do hereby release and forever discharge and hold harmless BELLWBIF and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with BELLWBIF.

Volunteer and Guardians understand that this Release discharges BELLWBIF from any liability or claim that the Volunteer and Guardians may have against BELLWBIF with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's Activities with BELLWBIF, whether caused by the negligence of BELLWBIF or its officers, directors, employees, or agents or otherwise. Volunteer and Guardians also understand that BELLWBIF does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

It is the policy of BELLWBIF that children under the age of 16 not be allowed on a BELLWBIF worksite while there is construction in progress. It is further the policy of BELLWBIF that, while children between the ages of 16 and 18 may be allowed to participate in construction work, ultra hazardous activity such as using power tools, excavation, demolition or working on rooftops is not permitted by anyone under the age of 18.

MEDICAL TREATMENT. Volunteer and Guardians do hereby release and forever discharge BELLWBIF from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with BELLWBIF or with the decision by any representative or agent of BELLWBIF to exercise the power to consent to medical or dental treatment as such power may be granted and authorized in the Parental Authorization for Treatment of a Minor Child.

ASSUMPTION OF THE RISK. The Volunteer and Guardians understand that the Activities may include work that may be hazardous to the Volunteer, including, but not limited to, construction, loading and unloading, and transportation to and from the work sites.

Volunteer and Guardians hereby expressly and specifically assume the risk of injury or harm in the Activities and release BELLWBIF from all liability for injury, illness, death, or property damage resulting from the Activities.

INSURANCE. The Volunteer and Guardians understand that, except as otherwise agreed to by BELLWBIF in writing, BELLWBIF does not carry or maintain health, medical, or disability insurance coverage for any Volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

PHOTOGRAPHIC RELEASE. Volunteer and Guardians do hereby grant and convey unto BELLWBIF all right, title, and interest in any and all photographic images and video or audio recordings made by BELLWBIF during the Volunteer's Activities with BELLWBIF, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

OTHER. Volunteer and Guardians expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of New Hampshire and that this Release shall be governed by and interpreted in accordance with the laws of the State of New Hampshire. Volunteer and Guardians agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
